Providing work opportunities to our stakeholders, grassroots artisans and farmers - being our priority, we need to continue our work in this direction. It is a matter of satisfaction that on behalf of the Forum, we were able to present policy papers to the Government for the 12th Five Year Plan. Secretary's Note



It is a pleasure to report on yet another full and active year for FTFI, one in which we have all continued to take the important message of Fair Trade forward. The efforts that FTFI has made over the last three years have started to bear fruit. The challenge now is to make FTFI ever more relevant, more focused, more result-oriented, and able to demonstrate more multiplier effects.

There is much that FTFI-I, as India's national Fair Trade network, can do to help members make the most of opportunities and position themselves better in the global market.

We already have the FAIR TRADE INDIA brand and the GiFT programme. We've also worked to raise the profile of Fair Trade in government over the last year. Ideas for more ways for FTFI to demonstrate practical value are always welcome – please do let us know any ideas you have, opportunities you know of, or things that you have tried and have worked well. The EC is working to address future market demands and the requirements of its members through a long-term strategy. The development of that strategy should be inclusive and participatory, which means that we look to our membership to contribute to FTFI's objectives and means of achieving them.

Our future strength will depend in part on the way we build relationships. We need to work with partners, both current and future, to expand and reach out to the market. The way we build partnerships will be one of the most important measures of our efficacy as a network.

The FAIR TRADE INDIA brand received a good deal of attention during the year, with new merchandise and gift hampers developed to promote the brand. Tee-shirts were also produced and distributed to proud wearers at the Fair Trade Day celebrations. Some 27 shops were brought under the brand. Two significant fairs – one showcased fairly traded garments, while the other showcased winter products organised by Mesh in their shop to promote the brand is replicable model for the other shops as well. The

ReFashion, competition was promoted across the country in September in partnership with the Pearl Academy. The creations by students on the theme of 'Recycle, Reuse and Reinvent' in the competition were encouraging, and offered a tantalising glimpse into India's enormous pool of creativity and capacity to produce trendy sustainable products. The winners received their awards at the Fair Trade Fortnight in New Delhi in December. Later in the year, we were fortunate to host Marina Spadafore, a designer from Italy, who conducted a programme on the latest trends for Autumn and Winter 2013-2014. Representatives from eight organisations were able to benefit from her insight and understanding, and the workshop resource materials were shared with all members.

More than 150 delegates enjoyed the annual FTFI-I national conference, which was held in Goa in October 2012. A solid few days of meetings, reports, networking and more ended with the AGMs of WFTO Asia and FTFI, which led to the election of your new executive committee.

The Fair Trade Fortnight was a highlight of the year, and provided an excellent opportunity to bring Fair Trade to the notice of ever increasing numbers of people in India. About a quarter of FTFI-I member organisations held a programme and a major event in Delhi at the end of the fortnight highlighted issues relating to child labour.

In Kolkata, a Fair Trade Fair in December organised with Sasha's help attracted many organisations, who recorded positive sales over the four days.

The Cotton Project (FTSC) closed with a grand ceremony in February in Tirupur and Nepal. Prototypes were developed by 21 members and a small fair trade exhibition was also held. For the first time, FTFI-I successfully collaborated with FIEO at the Gift Fair in March, which saw a joint FTFI/FIEO exhibition in which 16 members participated. The success of this and other partnerships bodes well for extending the fair trade message, and is something that FTFI should look to build upon in the future.

Fair Trade – The Way Forward was a film that was completed and distributed to members. The film chronicles a history of fair trade, and was widely appreciated.

Looking ahead, there is much more work for FTFI-I to do to promote fair trade in India and beyond. FTFI will continue to provide value to its members and contribute to the great goal of making fair trade an increasing presence in the retail and wholesale environments.

Adivasi Mela, Bhubaneswar

FTF-I supported participation of four members in the Adivasi Mela organized from 26th January to 9th February 2013 at Adivasi Exhibition Ground, Bhubaneswar, Orissa. Orupa, Anwasha, Unnayan and Kala Aparajita were the members, who participated in the Mela. Orupa coordinated the participation of the members on behalf of FTF-I.

The main attraction of the Mela was the 'Tribal Village' where more than 29 tribal huts of different tribal groups were set up, which showcased skilled art and craft used in the daily life of the tribals. The Mela, organized every year is considered the oldest and the most colorful festival of tribal people where all the 62 tribes from Orissa come over to the exhibition ground to spread out their ethnic mosaic. Adivasi Mela – the ethnically vibrant cultural festival, tone of the most attractive agenda of SC and ST Development Department of Orissa government.

Fair Trade Fair, Kolkata

The Fair Trade Fair was organised from 12th to 16th December 2012 at Ice Skating Rink, Kolkata. Twenty members of FTF-I participated in the Fair. The products exhibited in the Fair included garments, natural fibre products, quilts, tribal products, jewellery, incense, kalamkari, leather, bags, wooden toys, candle and paper mache. The total sale of the Fair crossed Rs. 10,00,00/-.

Gift Catalogue

FTF-I Published the FAIR TRADE INDIA Gift catalogue of corporate gifts by featuring products from 10 organisations. The catalogue is being marketed to potential corporate clients. The catalogue is the first of its kind prepared by FTF-I. In continuance to this FTF-I is making an extended data base of corporate gifts towards responding to the enquiries for gift products.

International Handwoven Fair 2013

FTF-I's participation in the India International Handwoven Fair 2013, Chennai was coordinated by SIPA. Visitors from countries such as Sweden, Canada, Australia and USA visited FTF-I's stall in the Fair held from 5th to 7th March 2013. Four FTF-I members – BCLA, SIPA, Imagination and Kalatmak Handicrafts participated in the Fair. The products featured by FTF-I members included Kalamkari textiles, handloom towels, home items, hammock, bags, scarves, Chicken embroidery items and Tape Loom bags.

Training on Spring Summer trends 2014

Marina Spadafora, Creative designer of CTM Altrmercato organised a workshop on Fashion Basics, Quality of Fashion and Spring Summer trends 2014 at IIC New Delhi to provide support for Fair Trade

handicrafts and handloom based organisations working with FTF-I. She also shared some of the technical handbooks, which can be referred by Fair Trade artisans. Eighteen participants including designers and marketing personnel from Indian Fair Trade handicraft organisations attended the meeting. The workshop was also helpful to discuss the future requirement of design support for the artisans working with Fair Trade Forum – India.

FAIR TRADE INDIA brand

The FAIR TRADE INDIA brand stands for the shops, which sell fairly produced products in India. So far 25 shops have come under the brand. Currently, the brand is given only to the shops owned by members of FTF-I. In the last financial year the turnover of shops crossed Rs.11 crores. At present, artisans, farmers and workers associated with 55 Fair Trade organizations are getting benefitted from the 25 FAIR TRADE INDIA branded shops. Seven shops came under the brand during the last financial year.

The brand ensures that the money paid by consumers is translated into development of grassroots producers- artisans and farmers down the supply chain in India. FAIR TRADE INDIA brand has been developed with the support of European Union under ProSustain project, being implemented by FTF-I in partnership with HIVOS.

Projects



Child Labour Project

The project named 'Sustainable solutions in the fight against child labour in home-based craft production' seeks to ensure the rights and development of children working in the home-based crafts sector in Northern India. The main aim of the project is to develop a model, which can be replicated by governments, industry, non-governmental organisations and child welfare agencies to provide sustainable solutions to child labour. Hence the project will be taking the views and concerns of the children and families involved into account. This project, supported by the European Union is a joint initiative of Traidcraft Exchange, UK, Centre for Education and Communication (CEC), FTFI, and Shop for Change.

Research to understand complex issues surrounding child labour in the Indian craft sector will be done towards "developing a model addressing the root causes of child labour in the home, such as low adult wage", as part of the project. Testing and refining the model will also be done before producing a guidance document to be used by different stakeholders.

FTF-I had planned various events and meetings in different project areas of Delhi and Firozabad to ensure greater visibility of the project and also to involve the larger people and beneficiaries in the project. To ensure greater project mileage FTF-I is having regular dialogue with

government agencies involving Labour, Health, Education and Handicrafts Departments on priority along with other government agencies. Three national level meetings were held on 11th December'12 (Multi stakeholder meet inviting various members of FTF-I), 13th December'2012 (National consultation workshop on child labour in association with CEC) and one National Multi-stakeholder group meeting on 26th February'13 inviting various government agencies, exporters, retailers, NGOs and INGOs to share the project approach with larger group.

Our Project partner CEC is leading the research part under child labour project. CEC has shared their initial mapping and empirical research report with all FTF-I and non FTF-I producer groups. The research data was collected from 64 different locations across Delhi and Uttar Pradesh. A learning center model to address the child labour issues is in place. Research report is made available to all by CEC.

ProSustain

The project 'ProSustain – Promoting Fair Trade and Sustainable Consumption in India' has helped FTF-I to organise several promotional and market access initiatives during the year. The project supported by the European Commission was a joint initiative of Hivos, FTF-I, IRFT and Shop for Change.

Under the project Fair Trade and Sustainable consumption was introduced to students through awareness programs and fairs organised in campuses. These Fair Trade awareness programs have helped FTF-I as well as several member organisations to develop partnership with Education Institutions to promote the concept of Fair Trade and products. A campus kit was developed to be distributed at the campus for greater visibility through students.

The FAIR TRADE INDIA brand for retail shops owned by FTF-I members and GiFT – the corporate gifting program are the other initiatives being taken up under the project, which will help to build domestic market in the days to come. Twenty five shops came under the umbrella of FAIR TRADE INDIA brand up to March 2013. The corporate GiFT program is also co-branded under FAIR TRADE INDIA towards extending the visibility of Fair Trade among the corporate sector. FTF-I is also working on the ways to extend the benefits of the brand to the members who are not at present running retail shops as well as to the online stores of FTF-I members. Corporate gift hampers were created with a view to capture the corporate market for fair trade.



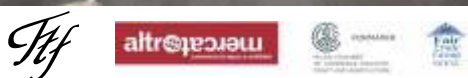
Fair Trade Cotton

The project "Fair Trade Supply Chain Development in India and Nepal", the project that was launched in March 2010 concluded successfully in February 2013 by paving way for a set of actions to make cotton as a trendy, effective and sustainable option for livelihood generation, consumption and a better environment. The project was supported by the European Union. FTF-I, Formaper-Italy, CTM Altromercato-Italy and Fair Trade Group Nepal were the partners of the project.



The project has created many visible and sustainable impacts through functional networking created between various actors in the cotton supply chain. Above all, the project consortium could respond to one of the long standing demand for 'Fair Trade – Organic fabric' of Fair Trade organisations, which produce garments and accessories. During the last three years the project team could expand the partner base into a virtual consortium of farmer groups, cotton processing (ginning, spinning, weaving, knitting), garment making and marketing organisations, which agree to follow Fair or Ethical and organic practices.

During the project period two partners in the project – Chetna Organic and Assissi Garments became the members of FTF-I. Towards the end of the project, 21 FTF-I members – Kalatamak Handicrafts, Pardada Pardadi, MESH, Usha Exim, Sadhna, Sabala, SIPA, Creative Handicrafts, Auomira Exports, Calcutta Rescue, Sahaj, The ANTS, JKSMS, Literacy India, Aagor Dagra Afad, Pushpanjali, Moral Fiber, Women India Trust, The Last Forest, Bethany Colony and Sasha – developed sample designs of products by using the Fair Trade organic fabric sourced through the partnership evolved through the project. The Nepal contingent also displayed their designs at the Tirupur seminar.

The FK Fellows were given opportunities to learn important areas of business such as brand promotion, retailing, packaging, product designing, visual merchandising and corporate gift marketing. One of the fellows was given learning opportunity in making glass motives by Pushpanjali Fair Trade. All the fellows were also given training in organising Fair Trade promotion programs in campuses.

The Asia Conference on 'Building Consumer Confidence' was organised at Bogmallo Beach Resort, Goa on 9th to 12th October 2012. Rudi Dalvai, President, WFTO (World Fair Trade Organisation), Ravi Jayawardena, President, WFTO Asia, Board members of WFTO, WFTO Asia and FTF-I as well as 250 participants hailing from different Asian countries (including CEOs, activists from Fair Trade organisations) participated in the conference. Nelly Rodrigues, President, District Panchayat, South Goa inaugurated the conference. In the inaugural session, Jabeen Jambughodawala president, FTF-I welcomed the participants to the conference. Shanthi Bai, a Lambani women working with Sandur Kushalakala won the UNESCO Award of Excellence for Handicrafts in South-East Asia and South Asia. The award for the year was given for the Banjara Wall Hanging made by her. The award was established to encourage the craft sector to preserve cultural diversity and traditional skills and knowledge in an increasingly competitive context. The award aims to promote high standards of quality and authenticity, while encouraging artisans to consider the relevance and function of their creations. Shanti Bai, was earlier awarded 'National Master Crafts person's Award for the year 2001.

Toda Embroidery Gets GI Status

The Toda embroidery (by the Toda community) of the Nilgiris has been granted Geographical Indication (GI) status for their unique embroidery, which is known for its striking colors. The GI status was given in March 2013 by Chaitanya Prasad, Registrar of Geographical Indications. The recognition came after five years of effort by Toda Nalavaazhvu Sangham, Keystone Foundation and Poompuhar (Tamil Nadu Handicrafts Development Corporation). District Collector Archana Patnaik handed over the certificate to the representatives at a formal function. The function was also attended by Mr. Jilani of Win Lexis that supported the initiative for GI status, Mr. Prasanth from the Registry of Geographical Indications, Mr. Prem Kumar, Marketing Manager of Poompuhar, Ms. Geetha Srinivasan of INTACH, Dr. Tarun Chabra, patron of tribal community and Kottradu Kuttan, Head of Toda Nalavaazhvu Sangham.

The GI status not only ensures uniform pricing for Toda embroidery products but also insulates the art from being duplicated. Of the nearly 1,600 tribal people in nearly 69 hamlets, a little more than 400 are said to be actively involved in embroidery.

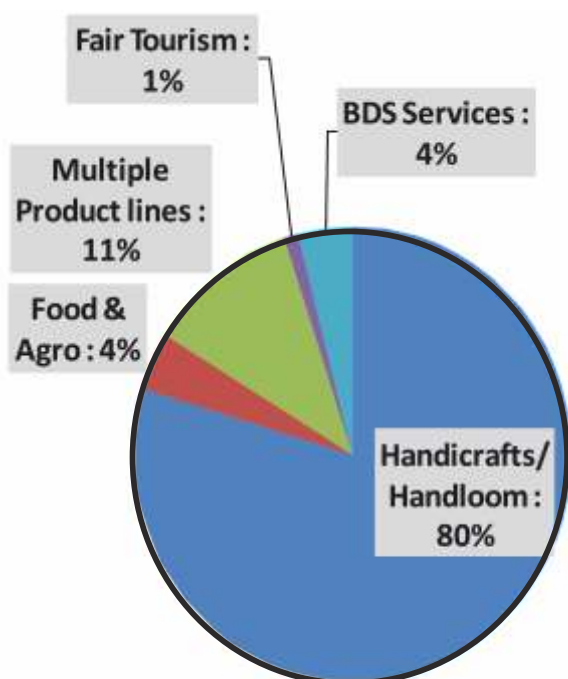

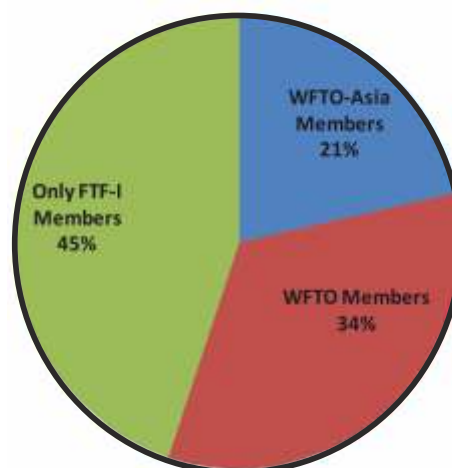
