"Orange the World" was the theme of this year's activism.




16 Days of Activism is an annual campaign celebrated by the global civil society that aims to raise awareness and advocate for the abolition of Sexual and Gender-Based Violence.

### Session on Mental Health, Well-being and Livelihood (for CFs of STREE)



Covid-19 has caused significant adversity and distress among the marginalised and vulnerable, particularly producers, , artisans and farmers.

During a review mission with member organisations and other CSOs as part of the STREE project, we discovered that a lack of employment opportunities impacts daily functioning, behaviour, and interaction among families and communities. This aspect, however, is the most neglected, and there is very little awareness.

To address this concern, we organised a session on Mental Health, Wellbeing, and Livelihood for the STREE project's Community Facilitators on November 22, 2021. The session was led by Paulomi, a professional mental health counsellor and cofounder of the organisation Well Heard.

### Partnership with American India Foundation Fellowship Program

In November 2021, FTFI was selected by American India Foundation to host one AIF Banyan Impact fellow after a rigorous process.

#### A virtual roundtable: Strengthening the anti-trafficking ecosystem in India

FTF-I was invited in virtual round-table organized Thomson Reuters Foundation on Strengthening the antitrafficking ecosystem in India. The panel discussion was a multi-stakeholder event that brought together senior representatives from India's private sector, civil society, and media freedom organizations. The event invited participants to explore innovative and collaborative approaches to strengthen the response to human rights abuses in supply chains and beyond through presentations, Q&A, and roundtable discussions. The event's goal was to lay the groundwork for a committed network of stakeholders to launch a collaboration to strengthen the Indian ecosystem and contribute to a more potent and effective response to human trafficking and forced labor abuses in the country.

O.P Yadav (E.D of FTF-I) and Anchal Kumar (Program Manager), as a panelists, expressed their views on role of civil society and collaborative approaches to strengthen the anti-trafficking ecosystem in India and how the Fair Trade Forum India Menber organisations are creating sustainable and safe value chains in the craft sector.












# <u>Collaboration with IIT</u> Jodhpur through internship programme

#### **UNHCR Project- Swavlamban**

The Government of India has been strongly committed to assisting the asylum/refugee population under the framework of the Indian constitution.

The Fair Trade Forum-India has been an implementing partner of UNHCR India since 2018 for the Swavlamban "Self Reliance Support to Refugee Men and Women" project. "Swavlamban aims to broaden the protection space for the refugees protected under the mandate of UNHCR India, by generating livelihood opportunities in the local economy.

After four successful years, the agreement of the project Swavlamban's has been ended on 31st December 2021. From October to December 2021 total of 138 POCs (Population of concerns), women-headed households have been provided support of INR 34,50,000. These livelihoods support were given in the form of micro-business grants in Delhi-NCR, Jaipur and Mewat. An additional target under the multi-partner trust fund. We have also supported 25 POCs in Delhi-NCR under the regular project. An implementation arrangement was done by J.K.S.M.S, Believe India, The Child Trust, Archisha, Conserve India in Jaipur and Mewat.


All the micro-grants have been utilized by the POCs to start their own businesses mainly tailoring shops, grocery stores and beauty parlors.

## CF Training in South Region

Thrissur, Kerala - (24th-26th) October 2021:

Our Community-Level Facilitators training in Thrissur, Kerala, focused primarily on design thinking and product innovation. Twenty-six Community Level Facilitators (twenty-three women and three men) from six CSOs in Tamil Nadu and Kerala participated.

### CF Training in East Region

2.Kohima, Nagaland - (16th-18th) Dec. 2021

This programme aided in the capacity building of community facilitators and craftsmen in the areas of design, product creation, market demand understanding, and Fair-Trade Practices. URA Collective participated in this CF Training.




2. Imphal, Manipur - (18th -20th) Dec.2021

The CF training workshop on Design Thinking and Product Innovation at Imphal took place from 18th to 20th December 2021. FTF-I organized the event in Hotel Yaipabha, Imphal, Manipur, which saw the participation of 4 CFs and one translator from across 3 CSOs in Manipur. Master Trainer Ms Melody ZAIREMMAWI conducted the workshop; she delivered the 3-day workshop in English, Hmar& Meetei Loan languages to facilitate the CFs from varied tribes and communities of Manipur. The workshop was a success due to the immense support from Ms K. Shangnaidar Tontang from Weaker Section Development Council (CSO), Mr Filler Duidang from Hao Craft (CSO) and Ms Melody from Rural Women Upliftment Society (CSO).

#### COMMUNITY-LEVEL WORKSHOPS:

The community-level facilitators of FTF-I conducted design thinking workshops in their community groups. A series of FGDs and Fair Trade workshops were held by community facilitators, with mentoring support from Master Trainers. These helped the artisan groups to understand and integrate Fair Trade practices within their working and inculcate an understanding of how to manage their internal systems, gear up for production in tune with market demand, and benefit of getting collectivized to reach economies of scale.









Each community-level facilitator facilitated learning for 40 women and was paid a fixed honorarium and organizing cost. Altogether 10,000 women artisans participated in these workshops across the four Regions.

The Community Facilitators used a toolkit designed by FTF-I that included a facilitation guide, image cards, and other required materials to conduct community-level design thinking and Fair Trade sessions.





### Annual Monitoring Workshop:
