# **Thoughts for Action & Reflection**

Good day.

Through this Newsletter, I am happy to share my thoughts with all the Stakeholders - Members, Supporters and Well-wishers of Fair Trade concepts & ethical consumerism.

As you all know, in the AGM held on 29th Jan, a New team has been elected from the previous Board. More details and thoughts from these Members will come in the next issues of Newsletters.

I am happy to be back again as President of this National Network after 2 decades (having served as Founder President from 2000 to 2003 and moving the Secretariat from Chennai @ SIPA to New Delhi with Tara Project, to begin within 2003 and passing on to Prof. Shyam Swarup Sharma). I am equally happy to see the growth of this amazing organization, with increasing membership and the reach-out, and now being busy with UNHCR and EU funded projects.

While reviewing the progress, I had seen that there is a great need to network & strengthen the Membersbase, work on the needs and aspiration of Members; and the urgency to build visibility and facilitate expansion of marketing opportunities for Fairly traded products. So also I strongly believe in working closely with Consumer Forums in promoting/strengthening ethical consumerism by making available the fairly made product-range – garments & textiles, food and a range of crafts in the mainstream markets across the Country. So also there is a need to walk to talk on Fair Trade concepts & standards among Young Consumers – as they are the future and as promising ethical consumers could demand fairly produced product-range, be it food, garments or crafts they buy.

And as we have nearly 200 social enterprises associated with our National network across the country, it is the time to strengthen our linkages with the Government at various levels, enabling & lobbying with the Policymakers for a better understanding that the "fair trade (standards) will enable fairness for all" and thus Government to align & implement fair trade policies in Govt's interest.

And, we now see lots of efforts and new initiatives by both State & Union governments – relating to skillbuilding, EDP & support towards self-employment with much financial support, Make in India, Pan India efforts and support & facilitation to Women empowerment & Entrepreneurship, and women leadership, in all areas and implementing fair wages in the marginalized and unorganized sector. So it is a great opportunity for Fair Trade Forum – India to join & strengthen the hands/efforts of the Govt in building up their efforts. However, we need to carefully watch the developments and set examples by several experiments as to how Entrepreneurial initiatives with Fair Trade standards (and being a Guaranteed Fair trader) would mean to the Producers / Consumers and to the Policymakers as this will enable a win-win situation – focussing "sustainable development for all"...

I would like to assure you that the Directors in the present Executive Committee are committed to strengthening this Network towards "collective voice and identity" - in strengthening grass-root initiatives and enabling thousands of Marginal artisans, Weavers & Farmers in becoming Fair Trade entrepreneurs and People with self-dignity & pride in their work - thus customise our pursuits to become self-reliant and sustainable livelihood models for replication & Ribble effect. More thoughts will come in the next Newsletter.


The Annual General Meeting began with the presentation of the report for consent to organize the AGM virtually.

## SOUTH: COMPLETED 52 COMMUNITY LEVEL WORKSHOPS:



During the month of February, the Southern region successfully conducted TOTs for Master Trainers, Community Facilitators, and Artisans in Kerala, Karnataka, Andhra Pradesh, and Tamil Nadu.

In total, 1020 women artisans from the region were trained, resulting in the capacity building of community facilitators and artisans in design thinking, product development, understanding of market demand-driven production, and Fair-Trade practices.

It also raised awareness of the STREE project and the importance of adhering to fair trade principles within the region's government and local authorities.











## WEST: COMPLETED 4 COMMUNITY LEVEL WORKSHOPS:



A total of 80 artisans were trained as a result of the four successful communitylevel trainings, which resulted in the capacity building of community Facilitators and artisans in design thinking, product development, market demand-driven production, and Fair-Trade Practices.

It also raised awareness of the STREE project and the importance of adapting to fair trade principles among the West region's government and local governments.



## **Vision Spring**



While most craft- workers rely heavily on their eyes, the likelihood of refractive errors among artisans and weavers is extremely high. They are the ones who have very limited access to eye care facilities as well as abysmal awareness. To combat the hidden disability of refractive errors, Fair Trade Forum India and VisionSpring have collaborated to screen up to 50000 artisans and weavers across India in the operation areas of member organisations and provide eyeglasses to those who need them

During the CLEAR VISION INDIA 2022 conference, Ella Gudwin, CEO of VisionSpring, Anshu Taneja, Country Director, Ms Moon Sharma, Treasurer of FTF-I, and Mr Anchal Kumar, Executive Director of Fair Trader Forum India launched the partnership at the Indian Habitat Centre on March 29, 2022.
